BOB WHIE CLUB PROPERTY – PENDLETON COUNTY

DEER TURKEY SMALL GAME HUNTING

VEHICLES MUST BE PARKED IN DESIGNATED AREAS ONLY, NEAR GATES AND NEAR BARNES.

IDENTIFY VEHICLE WITH MEMBERS NAME AND BADGE NUMBER PLACED IN A VISIBLE LOCATION IN THE VEHICLE.

ALL HUNTING MUST BE CONTAINED WITHIN THE PHYSICAL BOUNDARIES OF THE CLUB PROPERTY. IT IS YOUR RESPONSIBILITY TO KNOW THE BOUNDRIES OF THE PROPERTY PRIOR TO HUNTING.

PLEASE RESPECT OUR NEIGHBORS!

HUNTERS MUST ADHERE TO ALL STATE GAME LAWS. ANY LEGAL WEAPON MAY BE USED AS IS APPLICABLE FOR THE PERMIT HELD.

OVERNIGHT CAMPING WILL BE PERMITTED IN DESIGNATED AREAS NEAR GATES, NEAR OR INSIDE THE BARNES. NO FIRES INSIDE THE BARNES. FOR NOW NO CAMPING ON THE NEW 80 ACRES.

ALL BUILDINGS /BARNES ARE OFF LIMIT 2019-2020 ON NEW 80 ACRES.

PLEASE REMOVE ALL TRASH. POLICE YOUR CAMP SITE

PERMANENT TREE STANDS ARE NOT PERMITTED

NO MORE THAN TWO (2) PORTABLE STANDS OR GOUND BLINDS MUST BE IDENTIFIED WITH MEMBER NAME AND BADGE NUMBER.

STAND/BLINDS MAY BE PLACED AFTER YOUR PERMIT IS PICKED UP FROM THE CLUB HOUSE "BEHIND THE BAR".

YOUTH GUN HUNTING IS PERMITTED WITH AN ADULT CLUB MEMBER AND DURING YOUTH SEASONS.

YOUTH ARCHERY: ONE JUNIOR ONLY WITH BOW MUST BE WITHIN VISUAL DISTANCE NOT TO EXCEED 50 YARDS OF PERMIT HOLDER.

ALL DEER AND TURKEYS MUST BE REGISTERED AT THE CLUB HOUSE.

QUAD USE IS PERMITTED ONLY TAKING IN OR REMOVING TREESTANDS/GROUND BLINDS OR REMOVING HARVESED DEER. QUADS ARE NOT PERMITTED FOR SCOUTING OR JOY RIDING.

SPECIAL PERMISSION MAY BE GRANTED TO MEMBERS WHO HAVE MEDICAL CONDITIONS, AGE. ECT. COMMITTEE MEMBER/ BOARD DIRECTORS MAY GRANT PERMISSION.

ALL HUNTERS MUST SIGN IN ON MAP IN UPPER BARN "AT RANKIN MILL ROAD" DATE, STAND/ BLIND LOCATION AND BADGE NUMBER EACH DAY YOU HUNT.

LOCK ALL GATE WHILE ENTERING AND EXITING PROPERTY.

ONLY MEMBERS ARE ALLOWED TO HUNT. MEMBERS MAY TAKE NON-MEMBER TO ASSIST IN PLACING STANDS/BLINDS AND TRACKING AND RECOVERING WOUNDED DEER.

HUNTERS WITH PERMITS ENCOUNTERING NON-MEMBERS ARE REQUESTED TO ASK THESE INDIVIDUALS TO LEAVE THE PROPERTY. IF A CONFRONTATION OCCURS, NOTIFY LOCAL AUTHORITIES @ 859-654-3300 NON EMERGENCY OR EMERGENCY @ 911.

SMALL GAME HUNTING IS OPEN TO ALL MEMBERS. BE SURE TO IDENTIFY YOUR VEHICLES.

TREESTANDS MUST BE REMOVED AT END OF SEASON DUE TO INSURANCE

YOU MUST HAVE PERMISSION TO USE ^NANOTHER MEMBER'S TREESTAND/GROUND BLIND.

IF YOU DO NOT PICK YOUR PERMIT UP FROM BEHIND THE BAR PRIOR TO YOUR HUNTING DATES, YOU WILL NOT BE ELIGIBLE TO HUNT THE CLUB PROPERTY FOR 2 YEARS

COMMITTEE MEMBERS OR CLUB OFFICIALS WILL POLICE THE ABOVE RULES.

THE ABOVE RULES ARE TO BE FOLLOWED. ANY QUESTIONABLE ACTS OR BEHAVIOR WILL BE BROUGHT BEFORE THE BOARD OF DIRECTORS. THE BOARD OF DIRECTORS HAS THE AUTHORITY TO DISCIPLINE INDIVIDUALS INCLUDING POSSIBLE DISMISSAL FROM THE CLUB.
